Respected Sir/Madam,

We submit that our school, Tagore Public Senior Secondary School Jodhpur Rajasthan. We have registered on line for seeking affiliation from 2023-2024 onwards.

I would like to provide some background information about of the process. The Physical Inspection was conducted on 11/04/2023 and a virtual Review inspection on 06/10/2023. IC and RC inspection committee report positive and recommended. By RC Committee all rejection points are clear after that new additional fresh ground new objections by RC Rejection Latter.

Now school insure that all 10^{th} points clear and I request you application grant with condition Within 3 months all points submit with proof all points are clear as on today. Some document's and video link I provide you check and verify after that not agree give me option of Review committee.

After RC rejection some give mails by CBSE for submit deficiency. But our school direct reject so please request and grant with condition within 3 months.

I humble request you please consider my application and please grant with condition within 3 months. All the three science labs for Senior Secondary level are developed according sop so please I request you please grant with condition according other schools give me relief.

1. All the three science labs for Senior Secondary level are not developed and arranged as per the Board guidelines vide SOP dated 04.10.2022 (circular no 11/2022). In Biology and Physics labs work stations are temporarily arranged by adjoining small tables which are not suitable to conduct the related practical work. The apparatus are merely displayed on table without permanent fixtures. Chemistry lab is under sized with only one small work station. No standard safety measures are also adhered to as per the SOP. Plastic sheets are laid over small tables with carpet on the floor which are fatal and hazardous due to availability of chemicals and heating facility in the labs. Chemicals and salts are not under lock and key in chemistry lab. Gas cylinder is temporarily arranged for heating facility. The instruments are placed on the small slabs near the walls to do practical related work without any space. School should follow the SOP for labs and upgrade the labs accordingly before seeking affiliation.

Ans. School insure that Biology and Physics and Chemistry labs Swift another rooms(after ic rejection but time of rc all labs work going on rooms not complete date of rc now all labs according to sop) according to SOP guidelines workstation tables are 4*8 size all tables see in video. Already install all equipment fire alarm adjust fan fire executive and storage according to sop and CBSE Affiliation by laws. please see in video and according to RC suggestion carpet

already removed and gas cylinder remove now all three labs developed according to SOP and CBSE Affiliation bye laws.

- 2. The Composite science lab is temporarily arranged with one small table in the Centre and slabs along the walls which is not as board guidelines and suitable for practical works. Instruments are merely placed on slabs for display. Plastic sheets and carpet are laid which are not safe. Again, few chemicals are placed in open which is not safe and should be under locked cabinet/ almirah. School should arrange the Composite Science Lab as per the Board Guidelines vide circular no 11/2022 (SOP for recommended infrastructure for Lab, Library and Sports).
 - Ans. School insure that Composite science lab are all table 4*8(size) see in video. According to RC suggestion Plastic sheets and carpet are laid removed all labs. chemicals are placed in under lock School developed all Labs according to sop and CBSE Affiliation by e laws guideline.
- 3. Math lab is arranged with three small tables with few models and charts and without sufficient seating arrangements. Further, there is no computer system with internet facility for e-learning (as per SOPs) and to do the practical work with projects/modules. Lab should be upgraded and properly arranged as per SOP (circular no 11/2022).
 - Ans. School insure that Math lab arranged table size 4*8. computer system with internet facility all ready running in RC inspection video please see RC video. School developed math and computer labs developed according to sop and CBSE Affiliation by elaws.
- 4. The library is poorly stocked with temporary iron racks and are not properly catalogued and entered in accession register. Books and journals under different categories are not available. More library collection of classics, autobiographies, biographies, travelogues, essays, fiction, poetry, drama, recreational and motivational materials is required to be added. School is required to upgrade the library as per SOP and circular no 11/2022.
- 5. Ans. School insure that library is proper stocked According to students strength and According to sop all ready done. please see RC inspection video. now library new collection of classics, autobiographies, biographies, travelogues, essays, fiction, poetry, drama, recreational and motivational done library all new purchase bills attached. according to sop and CBSE Affiliation bye laws and upgrade the library as per SOP and circular no 11/2022.
- 6. School has not made the campus CWSN friendly as per the mandatory provisions of RPWD Act, guidelines vide 2016 and the Board circular 05/2023 no (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf). Ramps provided at the entrance of school building and inside the campus are of temporary construction with iron sheets. The ramp at the CWSN toilet is quite steep which is not suitable for smooth movement of wheelchair. The ramp to access the upper floor is steep and made of temporary iron structure without structural stability and not safe for the wheelchair bound CWSN. School should follow the circular no 05/2023 and provide the adequate infrastructure and facilities for CWSN as per the RPWD Act and the Board guidelines.
 - Ans. School insure that Ramps construction According to sop and CBSE Affiliation bye laws not a temporary iron structure please see RC inspection video. Ramps construction According to sop and CBSE Affiliation bye laws. Proper suitable for wheelchair. Ramp to access the upper floor is steep made metal permanent metal with structural stability according to sop and according circular no 05/2023 and provide the adequate infrastructure and facilities for CWSN as per the RPWD Act and the Board guidelines CBSE Affiliation bye laws.
- 7. The school has four building blocks but as per Fire safety certificate dated 25.08.2023 and Building safety certificate dated 25.04.2022, only three building blocks are covered under the certification. The residential block being part of the school campus is not covered for Fire and Building safety. Further, the Residential block for staff is not cordoned off from the administrative and academic blocks which should be separated to ensure proper safety and security of students. The school campus should be a compact one and be separated from other staff residential complex. School has not followed the proper safety standards as NCPCR guidelines and affiliation bye laws.
 - Ans. School insure that The school only 3 blocks please see in IC rejection letter and RC inspection video. Only 3 blocks 1.academic block 2. Management block 3.teachers quarters block for evidence please see proper RC inspection video and IC rejection later.(now fire safety certificate and Building safety certificate update according to RC rejection latter.) Now Residential block for staff (now residential block for staff quarters empty all staff members shift out of the school area) and administrative and academic blocks are separate according to ncpcr guidelines and affiliation bye laws(sop).
- 8. The general toilets for boys and girls are not properly developed. The boys toilets at ground floor are without permanent roof. The girls toilets are not clean and in hygienic conditions. School should follow the affiliation bye laws and the board guidelines for adequate infrastructure and hygienic conditions in toilets for safety of students.

Ans. School insure that According to RC suggestion general toilets for boys and girls are properly developed According affiliation by elaws and the board guidelines School insure that boys toilets at ground floor are permanent roof and hygienic conditions in toilets for safety of students. According CBSE Affiliation by elaws (sop).

- 9. The Outdoor and Indoor sports facilities are not arranged in the school as per Board guidelines. The playground is without required sports infrastructure and permanent marking for sports activities. The ground is completely sandy and not useful for sports activities. The school should develop the sports infrastructure as per Board recommendations and guidelines as per SOP dated 04.10.2022.
 - Ans. According to RC suggestion already developed Outdoor and Indoor sports facilities according to school should develop the sports infrastructure(permanent marking for sports activities) as per Board guidelines as per SOP dated 04.10.2022.
- 10. The school has a large kuchcha ground from the gate to the ramp at the entrance of the building, which would hamper access of CWSN and other students and staff particularly during the rainy season. The general toilets and washroom for students at ground floor are also accessible through sandy pathway. School should make the proper solid pathway for accessibility of campus and amenities
 - Ans. School insure that School ramp at the entrance of the building access for CWSN and other students for provide proper path for access ramp at the entrance of the building see in video general toilets and washroom for students at ground floor proper path concrete and pakka pathway for accessibility of campus and amenities according to CBSE Affiliation bye laws.
